

MEMBERSHIP APPLICATIONS TO SOUTH SHORE BOAT CLUB

1. APPLICANT MUST BE SPONSORED BY A NON-PROBATIONARY MEMBER OF THE SOUTH SHORE BOAT CLUB.
2. TURN IN THIS APPLICATION TO THE CLUB'S SECRETARY WITH A CHECK OR MONEY ORDER FOR \$675.00. (\$585.00 FOR DOCK/SOCIAL, \$575.00 FOR SOCIAL AND \$725.00 FOR FAMILY.) IF FOR ANY REASON, YOU ARE NOT ACCEPTED AS A PROBATIONARY MEMBER, THE FULL AMOUNT WILL BE REFUNDED TO YOU.
3. THE PROSPECTIVE MEMBER, OR MEMBERS, ARE TO MEET WITH THE BOARD OF DIRECTORS FOR SCREENING AT 6:00 PM, ON THE SECOND TUESDAY OF THE MONTH. IF RECOMMENDED TO THE GENERAL MEMBERSHIP, THE APPLICANT MUST APPEAR BEFORE THE GENERAL MEMBERSHIP AT 6:00 PM, ON THE THIRD TUESDAY OF THE SAME MONTH. IT IS AT THIS MEETING THAT THE ACTUAL VOTING FOR PROBATIONARY MEMBERSHIP WILL OCCUR.
4. PROSPECTIVE MEMBERS WILL BE PROVIDED WITH A COPY OF THE CLUB'S BY-LAWS AND WILL BE EXPECTED TO READ AND OBEY THEM. PROSPECTIVE MEMBERS MUST BE AWARE OF THE FOLLOWING:

A. Work Hour Program

1. All members must have completed nine (9) hours of work by July 1st of the current season. Those failing to do so, will automatically lose their membership effective July 2nd. The remaining nine (9) hours must be worked by December 1st of the current season. Those failing to do so, will automatically lose their membership effective December 2nd. After the probationary period, members can pay for all or part of their work hours at a rate determined by the Board of Directors.
2. Additional work hours may be assessed at the discretion of the Commodore. Additional hours assessed by the Commodore must be fulfilled by all members.
3. Members who serve as Dock Masters, Building Master, Yard Master, and Bar Chairmen shall be exempt of Club work hours beyond their area of duty, but not social obligations. In addition the Bar Chairman responsible for the supply of the bar and payments of invoices shall be exempt of all Club dues, and work hours assignments other than those which fall within the responsibilities of his office.
4. The Commodore shall have the authority to extend the work program closing date for members whose work assignments consist of maintenance, which must continue past the normal work program period.
5. Any member who is sixty-five (65) years old, and has a minimum of ten years in the Club, will be excused from the standard work hours required.

B. Social Requirements

1. All members must work at two socials per year. (Steak Fry, Bikini Contest, and 3rd of July) Commodore can increase this, based on special events.
2. A \$100.00 fine to be assessed to any member not working his/her assigned social.

C. Deadline on Work Hours – See Work Hour Program (A.)

D. Required Meetings

1. All members must attend three meetings per year or file a written excuse to the Board of Directors (which will be voted on at the following Board meeting and be entered into the Minutes for non-attendance). All members attending meetings must be present and sign roster before the start of “Old Business”.

E. Responsibilities of Members – See Membership Manual/By-Laws

F. Club Governance – See Membership Manual/By-Laws

G. Conditions of Probationary Membership

1. Applicants must be sponsored by a current member in good standing of the South Shore Boat Club, who is not a probationary member.

2. Submit an application form to the Club secretary with the application fee for the first year's probationary membership.
The prospective members are to meet with the Board of Directors for screening at the next regular Board meeting. Prospective members are to read the Club By-Laws before being screened, as pertinent questions will be asked regarding their knowledge of the Club By-Laws. (Membership applications are presented to the membership at the next regular monthly meeting (third Tuesday of each month)).
3. Voting for membership shall take place at this monthly meeting following introduction of the prospective members. All members elected shall be probationary members for two years, with regular membership status to be determined by a vote taken at the second Annual Meeting following their selection as probationary members. Permanent membership voting shall take place at the Annual Meeting, and all candidates shall be absent for the voting. To gain permanent membership shall require the same voting ratio needed for probationary membership. During their period as probationary members, all such members shall not have the right to serve in any club office, Board of Directors, or vote in any election. Probationary members shall have a key to the club in order to allow them to open the Club for cleaning purposes. Members accepted after June 1st will be voted on for permanent membership at the Annual Meeting following their 24th month as probationary members. Voting for members shall be by ballot only.
4. Any applicant not receiving at least eighty percent (80%) favorable vote of the membership voting would be termed not acceptable for membership, and would not be able to reapply for membership for a minimum of one year after the date of rejection. The application fee will be refunded by the club treasurer in case of rejection.
5. All new members under the age of twenty-one (21) will not receive a key to the Club until they turn twenty-one (21).
6. No one under the age of twenty-one (21) years will be allowed to join the South Shore Boat Club unless that person has an adult member in the Club. Any other exceptions to this By-Law will be brought before the Board members.

H. Annual Meeting

1. The Annual Meeting of the membership shall be held in January of each year. A majority vote of ballots cast at the Annual Meeting shall prevail on all issues, except for probationary members, which require eighty percent (80%) of ballots cast to remain a member. The secretary will be required to send a letter to all members prior to the Annual Meeting including the following:
 - a. The date of the Annual Meeting
 - b. The proposed By-Law changes
 - c. The Probationary members to be voted on
2. The Annual Meeting may be continued to the next month if deemed necessary through a majority vote of the membership present at the Annual Meeting. No further written notification for such is necessary.

I. Dues/Deadlines

1. The monetary amount of dues, fees and prices shall be determined by the Board of Directors at the annual November Board meeting for the following calendar year. The dues for 2020 dock \$275.00, dock social \$185.00, social \$175.00 and family \$325.00. There are also additional charges for member's boats with air conditioning (\$50) and refrigerators (\$35) and docks over 10ft 6 inches wide (\$50).
2. The first half (1/2) of dues must be paid by midnight January 1st. Those failing to do so will automatically lose their membership effective 12:01 a.m. January 2nd. A grace period of ten (10) days will be allowed, with a penalty charge of ten (\$10.00) a day for late dues, starting at 12:01 a.m., January 2nd. The second half of dues must be paid by midnight March 1st.
3. Money must be in the hands of the Treasurer, Commodore, or Secretary to be deemed paid.

J. Types of Membership

1. Dock: dock members shall be entitled to all club privileges and shall be assigned a boat slip.
2. Dock social: one who has all dock member privileges and obligations except is a partner with a dock member on a boat slip.
3. Club Social: One who has no boating interest. There will be no club social members allowed to hold an office or be a Board member in the Club.
4. Family: Entitles a husband and wife, who reside in the same household, to all Club privileges. A family membership entitles the family to 2 keys to the club, but allowed only one vote per family. There shall be 1 ½ times the current dock membership work hours required for family membership, and both members will be required to work the club's socials. The family membership will be \$50.00 more than the current club's dock membership. The family membership entitles a family to only one dock. Any person currently a member of South Shore Boat Club, Inc. wishing to upgrade to family membership understands that the additional proposed member is subject to the one year probationary period, however, the \$400.00 initiation fee will not apply. Any family memberships applied for by non South Shore members after January 1, 2020 will subject the entire membership, (not only individuals) to the two-year probationary period.
